The Board of Directors' meeting no. 8/2024 of Thai Wacoal Plc., held on October 21, 2024, resolved to approve International Laboratories Corp., Ltd. to use the ENFANT trademark and pay royalties to the company in 2024, with a budget not exceeding Baht 2,500,000.
